

## THE HAIRPOLITAN WEBSITE TERMS AND CONDITIONS

The following terms and conditions shall govern your use of our website. By using our website you are automatically bound by our terms and conditions and you are deemed to be aware of them.

### 1. Terms of Use

1.1 You may:

- (a) View pages from our website in a web browser or mobile platform; and
- (b) Download pages from our website for caching in a web browser subject to the other provisions of these terms and conditions.

1.2 Except as expressly permitted by this section or the other provisions of these terms and conditions, you must not download any material from our website or save any such material to your computer.

1.3 You may only use our website for personal use, and you must not use our website for any other purposes.

1.4 Except as expressly permitted by these terms and conditions, you must not edit or otherwise modify any material on our website.

1.5 Unless you own or control the relevant rights in the material, you must not:

- (c) Exploit material from our website for a commercial purpose; or

### 2. Prohibited Actions

2.1 You must not:

  - (e) access or otherwise interact with our website using any robot, spider or other automated means[, except for the purpose of search engine indexing;

- 2.2 You must not use data collected from our website to contact individuals, companies or other persons or entities.
- 2.3 You must ensure that all the information you supply to us through our website, or in relation to our website, is true, accurate, current, complete and non-misleading.

### **3. User Account Registration**

- 3.1 To be eligible for an individual account on our website, you must be at least 18 years of age.
- 3.2 You may register for an account with our website by completing and submitting the account registration details as provided.
- 3.3 You hold the discretion to allow third parties to use your account for which liability incurred you shall be personally liable.

3.4 You must notify us in writing immediately if you become aware of any unauthorised use of your account.

3.5 You must not use any other person's account to access the website, unless you have that person's express permission to do so].

### **4. User Login Information**

4.1 When you register for an account with our website, you will be asked to choose a user ID and password.

4.2 Your user ID must not be liable to mislead and must comply with the content rules; you must not use your account or user ID for or in connection with the impersonation of any person.

4.3 You must keep your password confidential.

4.4 You must notify us in writing immediately if you become aware of any disclosure of your password.

### **5. Cancellation and suspension of account**

5.1 We may:

- (a) suspend your account;

5.2 You may cancel your account on our website through your account control panel on the website.

### **6. Your Content**

6.1 In these terms and conditions, "your content" means all works and materials (including without limitation text, graphics, images, audio material, video material, audio-visual material, scripts, software and files) that you submit to us or our website and social media pages for storage or publication on, processing by, or transmission via, our website.

- 6.2 You grant to us a worldwide, irrevocable, non-exclusive, royalty-free licence to use, reproduce, store, adapt, publish, translate and distribute your content in any existing or future media related to this website.

- 6.4 Without prejudice to our other rights under these terms and conditions, if you breach any provision of these terms and conditions in any way, or if we reasonably suspect that you have breached these terms and conditions in any way, we may delete, unpublish or edit any or all of your content.

### **7. Your content: rules**

- 7.1 You warrant and represent that your content will comply with these terms and conditions.
- 7.2 Your content must not be illegal or unlawful, must not infringe any person's legal rights, and must not be capable of giving rise to legal action against any person.
- 7.3 Your content, and the use of your content by us in accordance with these terms and conditions, must not:
  - (a) be libellous or maliciously false;
  - (b) be obscene or indecent;
  - (c) infringe any copyright, moral right, database right, trade mark right, design right, right in passing off, or other intellectual property right;
  - (d) infringe any right of confidence, right of privacy or right under data protection legislation;
  - (e) constitute negligent advice or contain any negligent statement;
  - (f) constitute an incitement to commit a crime[, instructions for the commission of a crime or the promotion of criminal activity];
  - (g) be in contempt of any court, or in breach of any court order;
  - (h) be in breach of racial or religious hatred or discrimination legislation;
  - (i) be blasphemous;
  - (j) be in breach of official secrets legislation;
  - (k) be in breach of any contractual obligation owed to any person;

- (l) depict violence in an explicit, graphic or gratuitous manner;
- (m) be pornographic, lewd, suggestive or sexually explicit;
- (n) be untrue, false, inaccurate or misleading;
- (o) consist of or contain any instructions, advice or other information which may be acted upon and could, if acted upon, cause illness, injury or death, or any other loss or damage;
- (p) be offensive, deceptive, fraudulent, threatening, abusive, harassing, anti-social, menacing, hateful, discriminatory or inflammatory; or

### **8. Limited Warranties**

8.1 We do not warrant or represent:

- (a) the completeness or accuracy of the information published on our website;
- (b) that the material on the website is up to date; or
- (c) that the website or any service on the website will remain available.

8.2 We reserve the right to discontinue or alter any or all of our website services, and to stop publishing our website, at any time in our sole discretion without notice or explanation; and save to the extent expressly provided otherwise in these terms and conditions, you will not be entitled to any compensation or other payment upon the discontinuance or alteration of any website services, or if we stop publishing the website.

8.3 To the maximum extent permitted by applicable law, we exclude all representations and warranties relating to the subject matter of these terms and conditions, our website and the use of our website.

### **9. Limitations and exclusions of liability**

9.1 Nothing in these terms and conditions will:

- (a) limit or exclude any liability for death or personal injury resulting from negligence;
- (b) limit or exclude any liability for fraud or fraudulent misrepresentation;
- (c) limit any liabilities in any way that is not permitted under applicable law; or

(d) exclude any liabilities that may not be excluded under applicable law.

(a) are subject to Section 9.1; and

(b) govern all liabilities arising under these terms and conditions or relating to the subject matter of these terms and conditions, including liabilities arising in contract, in tort (including negligence) and for breach of statutory duty, except to the extent expressly provided otherwise in these terms and conditions.

9.3 To the extent that our website and the information and services on our website are provided free of charge, we will not be liable for any loss or damage of any nature.

9.4 We will not be liable to you in respect of any losses arising out of any event or events beyond our reasonable control.

9.5 We will not be liable to you in respect of any business losses, including (without limitation) loss of or damage to profits, income, revenue, use, production, anticipated savings, business, contracts, commercial opportunities or goodwill.

9.6 We will not be liable to you in respect of any loss or corruption of any data, database or software.

9.7 We will not be liable to you in respect of any special, indirect or consequential loss or damage.

9.8 You accept that we have an interest in limiting the personal liability of our officers and employees and, having regard to that interest, you acknowledge that we are a limited liability entity; you agree that you will not bring any claim personally against our officers or employees in respect of any losses you suffer in connection with the website or these terms and conditions (this will not, of course, limit or exclude the liability of the limited liability entity itself for the acts and omissions of our officers and employees).
